IMPORTANT POINTS AT A GLANCE

1. A Separate application should be submitted for each Test
2. The Candidates are advised to submit the filled in application well before the last date to avoid last minute rush.
3. The Computer Data Sheet should not be tagged or pinned to the application. It should be submitted separately along with the application.
4. Candidates who do not receive Original Hall Ticket can down load the same from the web site and attend the entrance test.
5. Mere appearance at the entrance test does not entitle a candidate for admission into a course unless the stipulated eligibility conditions are satisfied.
6. The Entrance test will be of 90 minutes duration and the question paper consists of 100 multiple choice type questions.
7. The candidates have to mark their responses (answers) on Optical Mark Reader (OMR) answer sheet by darkening the relevant circles with a HB pencil. A model OMR sheet is attached at the end of this booklet.
8. Admission is made by centralized counseling. Candidates have to appear for the entrance test and counseling at their own expense.
9. Notwithstanding any thing contained in this booklet, the rules and regulations that are in force in the University on the date of counseling will be applicable.
10. The candidates are advised to obtain the Transfer Certificate (TC), Marks Statements of the qualifying examination and the latest Caste and Income certificates wherever applicable, well in advance.
11. The candidates are required to submit all the relevant certificates and pay the required fee on the spot and no extension of time will be permitted.
12. No candidate will be admitted under any circumstances unless all the relevant certificates are submitted and the required fee is paid.
13. Admission into college does not confer the right for accommodation in the Hostel. A PG degree holder who wishes to pursue another PG course is not eligible for Hostel Admission and for any Scholarship.
14. **Refund of fee against cancellation of admission as per the University rules is allowed up to 15-07-2009. After this date, cancellations are allowed without refund of fee. The date of closing of admissions will be notified.**
15. **Withdrawal from any regular / self-supporting course after the closure of admissions will be allowed if the candidate pays the total course fee without any concession.**

PRESERVE THIS BOOKLET CAREFULLY

Common entrance tests are being conducted for admission into M.A., M.Sc., M.Com., M.B.E., M.Ed., M.F.M., M.L.I.Sc., M.S., M.Sc. Tech and M.Tech. Courses offered in the constituent and affiliated colleges of Sri Venkateswara University during 2009-2010. The admissions are governed by the SVUCET – 2009 rules and regulations given below. These rules supersede those that governed admissions in the preceding years. The Advisory Committee of Directorate of Admissions reserves the right to change or modify any of the rules.

1. GENERAL

- 1.1 Admissions are limited to only those candidates who are local to one or the other University areas of A.P. State.
- 1.2 Indian Nationals who are natives of other states (other than AP) are eligible for admission under National Integration Quota (5%) subject to satisfying the eligibility criteria and Rank in SVUCET-2009.
- 1.3 **Foreign nationals/NRIs** can be admitted **without entrance test** subject to satisfying the eligibility criteria and production of STUDENT VISA for the period of study in the University.
- 1.4 **P.G.Degree holders of a particular course / subject are not entitled for admission into the same course/subject. However, a PG holder can pursue another PG course in a different discipline but not eligible for hostel admission and any scholarship.**
- 1.5 No candidate is entitled to pursue more than one full time course at a time. If admitted, no candidate can undertake any other assignment or employment, or study any other course simultaneously with the exception of evening part time courses offered by the University.
- 1.6 If it is proved that any of the certificates submitted by a candidate was tampered or fake, the candidate not only loses seat but also is liable for prosecution.

2. COURSES OF STUDY

3 ELIGIBILITY FOR WRITING THE ENTRANCE TEST

- 3.1 The candidate should have passed the qualifying examination with a minimum of 40% marks in the concerned subject. For the courses where the admission is based on the degree as a whole, the aggregate percentage in the group subjects should be 40% of marks. For admission into M.Ed., the aggregate marks in B.Ed. should be 50% and the aggregate marks in degree/PG/ should be 45%. For admission into M.Sc. Tech in Hydrogeology, the aggregate marks in M.Sc. should be 50%. Pass is sufficient for SC/ST candidates.
- 3.2 The candidates who have appeared for the final year qualifying examination are also eligible to take the tests. But they should have passed the qualifying examination with requisite minimum marks by the time the SVUCET-2009 admissions take place.
- 3.3 Candidates who qualify themselves in the SVUCET-2009, but do not have the requisite percentage of marks in the qualifying examination or not satisfying the subject eligibility requirement are not eligible for admission.
- 3.4 Candidates who pass the qualifying examinations in September / October supplementary examinations of 2009 will not be eligible for admission during the academic year 2009-2010.

University payable at Tirupati with the Test Name and name of the applicant written on the reverse of the DD for each test separately on or before the last date given in this booklet.
- 4.3 If the candidates apply for a particular test and if found to be not eligible for that test, the test fee paid will not be refunded. Hence the candidates are advised to go through thoroughly the eligibility conditions given in the instruction booklet before applying.

5. HALL TICKETS

- 5.1 Hall tickets for the entrance test will be sent to the candidates 10 days before the date of test. However, candidates who submit their application with late fee, the test center will be allotted at TIRUPATI only and such candidates should collect their hall tickets from the office of the Directorate of Admissions at least one day before the test.
- 5.2 In case of non-receipt of original hall ticket, the candidates can download the same from the website and attend the examination OR he/she should contact the Chief Superintendent of the Examination centre at Kadapa or Nellore or the Directorate at Tirupati at least one day before the date of the entrance test with 2 passport size photos and a demand draft for Rs. 50/- drawn in favour of Director, Directorate of Admissions, S.V. University along with the evidence of having submitted the application, to receive a duplicate hall ticket.
- 5.3 SVUCET-2009 hall ticket is to be produced at the time of admission. The candidates are advised to preserve the hall ticket carefully.

6 PARTICULARS OF ENTRANCE TESTS

- 6.1 Entrance tests will be conducted at Tirupati, Nellore and Kadapa. Entrance tests for which the number of applicants is less than 750 will be conducted at Tirupati only. The Schedule of entrance tests is given in item 17.
- 6.2 There is prescribed syllabus for each entrance test as given in item 16. The syllabus of each test consists of Section A for 30 questions, Section B for 30 questions and Section C for 40 questions.

- 6.3 Each entrance test will be of 90 minutes duration with 100 multiple choice type questions. Each question carries one mark. A few model questions are given in Section 19.
- 6.4 The question papers for Computer Science, English, Space Technology and Hydrogeology tests will be only in English while language tests will be in the respective languages. For all other tests, the question papers will be in both English and Telugu.
- 6.5 No candidate will be permitted into the examination hall without proper hall ticket.
- 6.6 No candidate will be allowed to carry calculators, books, papers, mathematical and physical tables, slide rules, pagers, electronic organizers, digital diaries, cellular phones or any other calculating aid into the examination hall.
- 6.7 If the Government/University approves the starting of a P.G. course at a new centre after the last date for submission of filled applications but before the admissions are closed, all the candidates who qualify in the concerned test that makes them eligible for admission into that course will be considered for admission at the new centre also.
- 6.8 The different courses, the number of seats and the eligibility criteria for admission into each course along with the entrance test one has to take, are given below. (SS - Self Supporting seats, SP - Sponsored seats; all others are Regular seats; SVUC - SV University Campus) In all regular courses 30% of seats are available as payment seats. For details see section 13 on page 15.

- 6.9 In case of the course where there are seats with different eligibility criteria, the vacant seats in either category (after exhausting the complete list) can be filled with candidates of other category.
- 6.10 If the applications received for any test / course are equal to or less than the number of available seats, entrance test will not be conducted for that Course. However, the candidates will be admitted directly in such courses after verifying the eligibility criteria and marks in the qualifying examination.
- 6.11 Both Regular and Self Supporting Courses will be run depending upon the number of candidates admitted and viability.

7. RANKING

- 7.1 The minimum mark for qualifying in the entrance test is 25. However, for SC/ST candidates there is no qualifying mark.
- 7.2 When there is a tie on the basis of marks obtained in the test as a whole, it will be resolved on the basis of marks obtained in Section C. If there is still a tie, it will be resolved on the basis of marks obtained in Section B. If there is still a tie, it will be resolved as per seniority in age.
- 7.3 Rank cards will be posted to the candidates within ten days after the publication of SVUCET–2009 results.
- 7.4 Any candidate, who has lost or not received the rank card, the candidates can download the same from the website.
- 7.5 The rank obtained in SVUCET-2009 is valid for admission for the academic year 2009-2010 only.
- 7.6 There is no provision for REVALUATION or PERSONAL IDENTIFICATION OF ANSWER SHEETS.

8. ADMISSION PROCEDURE

- 8.1 The candidate should have passed the qualifying examination with minimum percentage of marks as mentioned in para 3.1, when he/she is called for the interview for admission, failing which the qualified candidates next in rank would be admitted.

- 8.2 All admissions pertaining to all the colleges would be made at **Tirupati only** by the Directorate of Admissions, S.V.University, Tirupati.
- 8.3 Admission into each course will be done by calling at least three candidates for every seat in each category. Candidates have to attend the interview at the allotted venue, date and time at their own expenses with the required documents and fees.
- 8.4 **If a candidate fails to attend the interview at the specified date and time for whatever reason (including non- receipt or delayed receipt of call letter), he/she will forfeit the seat and the candidate next in rank will be considered for admission. Any representation for postponement of the date and time of personal appearance will not be entertained.**
- 8.5 If a candidate reports himself/herself after the interview is over with some valid reason, such a candidate on written representation may be considered for admission into the course if only there is a vacancy in the particular category for which he/she is eligible.
- 8.6 At the time of interview, the following original documents should be submitted by the candidate:
1. SVUCET-2009 Rank card and Hall Ticket.
 2. Marks statements and Provisional/Degree Certificate of the qualifying examination
 3. Transfer and Conduct certificates (Admission will not be given if T.C. of the institution where the candidate studied last is not submitted)
 4. SSC and Intermediate pass certificates
 5. Six Passport size photographs
 6. Study certificates from IX class to qualifying examination
 7. Caste certificate in original from the Tahshildar in case of SC/ST/BC candidates, obtained in the year 2009 OR permanent caste certificate
 8. Two income certificates from the Tahshildar obtained in 2009 (for those who wish to apply for scholarship/fee concession). (Fee concession will not be given if income certificate is not submitted).
 9. Relevant certificate in case of physically handicapped/extra curricular activities (NCC/NSS/Games & Sports / Cultural Activity) category
 10. Discharge certificate and service certificate of the parent in case of a child of armed person.
 11. Residence Certificate of parents for stay in the state of A.P. from Tahshildar in case of Candidates, who have studied outside A.P./ carried out private study.
 12. Migration certificate (for other University candidates)
- 8.7 Admission list will be finalized on the day of interview on the basis of rank obtained in the entrance test and fulfillment of eligibility criteria subject to rules of reservation. Candidate who cannot produce all the necessary certificates at the time of counseling will forfeit admission and the candidate next in rank would be admitted. If selected, the candidate has to pay the prescribed fees immediately. The admission is purely provisional
- 8.8 The cases of pending revaluation will not be considered.

9. LOCAL AND NON-LOCAL CANDIDATES

- 9.1 The S.V.University area comprises of the districts Anantapur, Chittoor, Kadapa, Kurnool & Nellore.
- 9.2 The following candidates are treated as local to S.V.University area
- 9.2.1 A candidate who has studied in the S.V.University area (or stayed in case of private study) for four consecutive academic years ending with the academic year in which he/she has first appeared for the final year qualifying examination.
 - 9.2.2. A candidate who has studied (or stayed in case of private study) for seven consecutive academic years within the state of Andhra Pradesh ending with the academic year in which he/she first appeared for the final year qualifying examination and studied (or stayed in case of private study) for a maximum period in the S.V.University area.
 - 9.2.3. In case a candidate has studied (or stayed in case of private study) for equal periods in the S.V.University area and another University area out of the last seven years, he/she should have studied (or stayed in case of private study) lastly in the S.V.University area.
- 9.3 Any candidate who is not local to S.V. University is treated as non-local to S.V.University, if
- 9.3.1 he/she is local to any other University in Andhra Pradesh State.
 - 9.3.2 he/she resided for a total period of not less than 10 years in Andhra Pradesh (excluding the periods of study outside the State).
 - 9.3.3 His/her parents has resided in Andhra Pradesh for a total period of not less than 10 years.
 - 9.3.4 His/her parent/spouse is presently working in Andhra Pradesh in government or allied service.

10. ALLOCATION OF SEATS TO VARIOUS RESERVATION CATEGORIES

- 10.1 Among the seats sanctioned in each course, 85% of the seats are given to reserved categories of local (L) candidates, while 15% are given to local and non-local candidates (L/NL) on merit. The 85% reserved seats are filled by local candidates belonging to OC (Open Category), SC (15%), ST(6%), BC-A(7%), BC-B(10%), BC-C(1%), BC-D(7%), ECA (Extracurricular activities): NCC/NSS/Cultural Activities (4%) and one seat extra for

- Sports and Games in each course and college; PH (Physically handicapped) (3%) and CAP (Children of armed personnel) (2%).
- 10.2 A vacancy under SC goes to ST and vice-versa. If enough SC&ST candidates are not available, the left-over seats will go to OC.
- 10.3 A vacancy under BC group goes to any other BC group on the basis of in SVUCET-08 rank. If enough BC candidates are not available, the left-over seats will go to OC.
- 10.4 **Extracurricular Activities (ECA) Seats.**
Candidates proficient in the categories namely NCC, NSS, Games & Sports and Cultural activities and local to S.V.University are eligible for the ECA seats. **Participation during the period of study of the qualifying examination is alone considered.**
- Priority I :** International level participation in NCC.
International level participation in NSS activities.
International participation in approved World competitions / World competitions for Juniors / World University competitions in the order with the Priority to the winners.
International level participation in Youth Festival
- Priority II :** National level participation in NCC.
National level participation in NSS activities
National championship / Junior National championship / South zone championship participation in Games & Sports in the order with the Priority to the winners.
National level participation in Youth Festival with prize.
- Priority III :** State level participation in NCC or just 'C' or 'B' certificate holders.
State or Inter-university NSS camps or NSS two special camps
Inter-University / Inter District / Inter Collegiate place winners in Games & Sports in the order with the Priority to the winners.
South Zone level participation in Youth Festival (Priority for prize winners)
- 10.4.1 Under Games & Sports Category, participation in the following games and sports only shall be considered as certified by recognized bodies or associations: Cricket, Foot ball, Hockey, Volley Ball, Basket Ball, Tennis, Kabaddi, Shuttle-Badminton, Ball-Badminton, Table Tennis, Athletics, Swimming, Weight Lifting, Wrestling, Boxing, Gymnastics, Kho-Kho, Hand Ball, Chess, Cycling, Rowing Body Building and Shooting. Candidate shall have to produce the following documents
- a. Certificates issued by a recognized Sports Body or Association (Form I,II,III).
- 10.4.2 ECA general merit list will be prepared with candidates of Priority I arranged in the order of SVUCET-09 rank followed by candidates of Priority II arranged in the order of SVUCET rank followed by candidates of Priority III arranged in the order of SVUCET rank.
- a. When there is only one ECA seat in a course, it will be filled as per the order in the ECA general merit list.
- b. When there are two ECA seats, the first seat will be filled as per the order in the ECA general merit list. The second seat will be filled from the ECA general merit list by a candidate belonging to the category other than the category of the first candidate selected ensuring women reservation.
- c. When there are three ECA seats, one seat is earmarked for each category. The first seat will be filled as per the order in the ECA general merit list. The second seat will be filled from ECA general merit list by a candidate not belonging to the category of the first candidate selected. The third seat will be filled from the ECA general merit list by a candidate belonging to the remaining category ensuring women reservation.
- The left-over ECA seats will go to Open Category.
- 10.5 **Physically Handicapped (PH) Category**
PH candidates should enclose the attested copy of the certificate issued by the Medical Board of District Headquarters Hospital or General Hospital of a Medical College. The Certificate should indicate the nature and extent of disability in percentage.
At the time of interview, a physically handicapped candidate must submit the original PH certificate and appear before the Senior Medical Officer, SV University. Admission will be made on the basis of the percentage of disability as assessed by the Senior Medical Officer, but not according to the rank in the entrance test. Where handicap is equal, merit in the entrance test will be taken into consideration for admission. A physically handicapped candidate will not be admitted into a course if the handicap does not allow him to pursue the course to a reasonable extent. If there is no suitable candidate under PH category, the seat will be filled with a candidate of local open category.
- 10.6 **Children of the Armed Personnel (CAP) seats**
The following priorities shall be drawn up with regard to the children of armed personnel.
- i. Children of Servicemen killed in action.

- ii. Children of Ex-Servicemen disabled in action and permanently incapacitated as a result there of in respect of disability pension.
- iii. Children of Ex-servicemen and Servicemen who have received Gallantry Awards in the following order. (a) Param Vir Chakra; (b) Ashok Chakra; (c) Mahavir Chakra (d) Kirti Chakra; (e) Vir Chakra; (f) Shaurya Chakra; (g) Sena / Nao Sena/ Vayu Sena Medal; (h) Mention in dispatches.
- iv. Children of Armed personnel (combatant) irrespective of the rank held by them.
- v. Children of other Ex-servicemen or Servicemen who are eligible for pension.

If there is more than one candidate in any of the above groups, priority will be decided on the basis of SVUCET -09 rank.

10.7 **Reservation for women:** One third of the seats are reserved for women candidates in each category (i.e., OC, SC, ST, BC, ECA, PH and L/NL). This rule is not applied if women candidates selected on merit in a category form one third or more of the seats therein. If there are no suitable women candidates in a category, the seats will be filled with men candidates of the same category. Absence of adequate number of women candidates in a category cannot be compensated by giving more seats for women in another category.

10.8 **DISTRIBUTION OF SEATS**

The distribution of seats for different categories in courses with different number of seats is given below. In each category, the seats mentioned under 'W' (Women) will be first filled by available women candidates and then the seats mentioned under 'M' (Merit) will be filled by men or women candidates on merit. If women candidates are not available in any group, the left over seats will be filled by merit.
