Please also note that

- (1) The students admitted to MBA/MCA courses during 2010-11 shall continue to pay every year the same annual tuition fee as paid at the time of their admission till they complete the course.
- (2) The students who were admitted in the college prior to 2010-11 shall continue to pay every year the same annual tuition fee at the rate existing at the time of their admission till they complete the course.
- (3) The institution shall collect the Tuition fee in advance in a lumpsum or in installments.
- (4) The institutions are directed not to charge any capitation fee or any amount unauthorisedly or illegally under any other head or guise (e.g. donation etc.) either directly or indirectly, other than the fee fixed by the Admission & Fee Regulation Committee.
